Applications Invited to Serve on Five Assessment Stakeholder Subcommittees

The Assessment Stakeholders Committee invites all interested educators and community members including business representatives and representatives from higher education to apply for one of five subcommittees being formed in the effort to develop and adopt a revised system of statewide assessments.

Under the Colorado Preschool to Postsecondary Alignment Act, S.B.08-212 or the Colorado Achievement Plan for Kids, Colorado is required to adopt revised content

standards by December 2009 and to adopt a revised system of assessments that aligns with the updated state content standards by December 2010. The Colorado Department of Education is seeking applicants to participate in this assessment redesign process.

To guide this work, the 35-member Assessment Stakeholders Committee has created subcommittees to work on the following five topics:

1. School Readiness and Early Childhood Assessment
2. Postsecondary Readiness Assessment
3. Summative Assessment subcommittee (No Child Left Behind requirements)
4. Growth Subcommittee, including formative (interim or benchmark) assessments
5. Assessment for Special Populations

Applications for subcommittee membership will be accepted through Tuesday, Dec. 1. Subcommittee members will be notified of their selection by Monday, Dec. 14. The subcommittees will meet twice in January and twice in February 2010.
